#### **ENROLMENT POLICY:**

#### General

- These terms and conditions of enrolment apply to all participants who may enroll for any classes offered by SHARE by enrolling to a specific class/s, it shall be deemed that the participant agrees to be bound by these terms and conditions of enrolment General Conditions:
- The participant acknowledge that it is a condition of their enrolment that they abide by all SHARE policies and procedures
- The participant agrees to accept responsibility to inform SHARE of any changes in the information supplied on the enrolment form within the prescribed time period of which the participant is aware
- SHARE reserves the right to refuse admission to a class/s to any participant, the participant will be informed and fees refunded
- The participant must ensure the criteria for enrolment as stipulated in the class information have been met in full
- The participant must demonstrate acceptable behavior and ensure it does not contravene SHARE mission and vision statement
- The participant must not bring SHARE's reputation into question or disrepute by any inappropriate action taken
