## ENROLMENT POLICY:

### General

- If participant does not agree to be bound by these terms and conditions of enrolment, enrolment should not proceed
- These terms and conditions of enrolment apply to all participants who may enroll for any classes offered by SHARE by enrolling to a specific class/s, it shall be deemed that the participant agrees to be bound by these terms and conditions of enrolment
- General Conditions:
  - The participant acknowledge that it is a condition of their enrolment that they abide by all SHARE policies and procedures
  - The participant agrees to accept responsibility to inform SHARE of any changes in the information supplied on the enrolment form within the prescribed time period of which the participant is aware
  - SHARE reserves the right to refuse admission to a class/s to any participant, the participant will be informed and fees refunded
  - The participant must ensure the criteria for enrolment as stipulated in the class information have been met in full
  - The participant must demonstrate acceptable behavior and ensure it does not contravene SHARE mission and vision statement
  - The participant must not bring SHARE's reputation into question or disrepute by any inappropriate action taken
  - Participants to promote SHARE in a positive manner
  - The participant confirms that by submitting the enrolment form he/she indicates his/her willingness to register for the class and to accept all responsibilities for payment of class fees as set.

### Classes not suitable for those with cognitive impairment, dementia, or walking aids.

- As a safeguard to yourself and other participants, you must not participate in class if you have:
  - ◆ Unwell, have any flu like symptoms or confirmed COVID-19
  - ◆ Physical ailment, such as tinea, an open cut, sore or wound or incontinence – for water based classes only.
  - ◆ Other risk, however small, to other participants, Leader/s.

Payment methods: As indicated on the reserve of this form.

Classes must be booked and paid for in full in advance on Semester basis.

Once payment has been processed a receipt will be emailed to you only upon request. You are not required to take your receipt to your class.

Your enrolment is not complete and you are not entitled to attend class until you have paid the required class fees or exempted from SHARE fee and the participant will remain liable for the full class fee. New members can enroll at any time subject to availability and will be charged at the time of enrollment the pro-rata rate for remaining classes in the term.

SHARE reserves the right to:

- Run, withdraw or cancel any class and/or hold a class at any venue other than that advertised.
- Alter the times, dates or venue for the whole or part of the class and/or offer you a new/alternative class.
- If any of these class changes become necessary, you will be advised of the changes and the alternative arrangements

**Note:** SHARE is a not for-profit organisation committed to providing caring, affordable and sustainable classes. The participant consents that personal information may be used for communication about his/her enrolment and related activities. Please note this does not include your personal details such as name, address or private information.

### Refunds, Credits and Cancellations

SHARE does not accept responsibility for participants' non-attendance of classes due to changes in personal or business circumstances/commitments during the term.

SHARE does not offer make-up classes for non-attended classes. Participants who withdraw from a course within at least 5 working days' notice before the course begins may request a refund.

In the event that you are unwell and unable to attend your class/es a refund may be requested. By completing an application form, which can be obtained from the SHARE office Refund requests will be processed for medical reasons only with an accompanying medical certificate.

Backdated medical certificates will not be accepted. An administration fee of \$20 per course will be charged for processing refunds.

SHARE reviews the viability of each class prior to commencement of term.

- If SHARE cancels a course and a suitable alternative is not available, a full refund of your course fee will be issued.
- If SHARE cancels an individual class/es due to leader illness or a venue issue, we will endeavour to find a replacement leader/venue. If it is not possible to secure a replacement Leader/venue a class refund will be issued

Please allow 2 to 3 weeks processing for all refund types.

### Holiday

Classes do not operate on public holidays. Any exceptions to public holiday these fees will be marked with \*\* on the timetable.

### Pre-activity Questionnaire Consent Form
